

TO: North Carolina State Board of Elections

Howard for Wake County Sheriff has been running campaign Facebook Advertisements since September of 2020. The total spending of what is known is for campaign Facebook Advertisements from September of 2020 through February 10, 2022, reflect \$797.00 in total. These expenditures have not been filed with the NC Board of Elections, nor any recipients of contributions for that amount on any of Howard for Wake County Sheriff's campaign financial reports. Furthermore, Howard for Wake County Sheriff's campaign financial report for 2021 Year End Semi-Annual is incomplete and inconsistent with financial accounting for donations and expenditures.

A campaign video first published to Howard for Wake County Sheriff's Facebook page on November 21, 2021, was recorded and edited by CineMade Media, owned by Nick LaGrange. I inquired with Nick LaGrange about his services for pricing. Nick LaGrange stated that the media packages are \$10,000.00-\$15,000.00 for full branding. I questioned the affordability and inquired if Howard for Wake County Sheriff paid that price, which Nick LaGrange informed me that his campaign did in-fact pay \$10,000 for his services. I was concerned given the amount of money paid, which wasn't reflected on any of his campaign financial reports. Nick LaGrange informed me that a company named Brand Equation, owned by Lane Houk, paid \$10,000.00 for the full brand video and content creation around October 2021.

Howard for Wake County Sheriff did not report the \$10,000.00 donation on his campaign finance report and the amount was in excess of \$5,200.00 per election cycle, under § 163-278.13. Furthermore, Howard for Wake County Sheriff accepted campaign contributions from a business entity, Brand Equation, under sole proprietorship of Lane Houk, which violates § 163-278.19(a)1-3. There is no record of reimbursement to the business entity or amount loaned to the campaign regarding the amount of \$10,000.00 or the \$797.00 spent on Facebook advertisements, which is also over the \$1,000.00 threshold outlined under § 163-278.13(f)4.

I have attached the screenshots from Howard for Wake County Sheriff's public campaign Facebook page, which outlines the amount of money spent for advertising and the time stamps of when the posts were published. Nick LaGrange with CineMade Media provided this information through direct conversation with David Blackwelder.

Given these financial illegalities and the timeframe of the upcoming candidate filing for office, I request expediency for an investigation to this unlawful conduct. We cannot have an elected Sheriff who engages in unlawful financial reporting practices and illegal conduct.

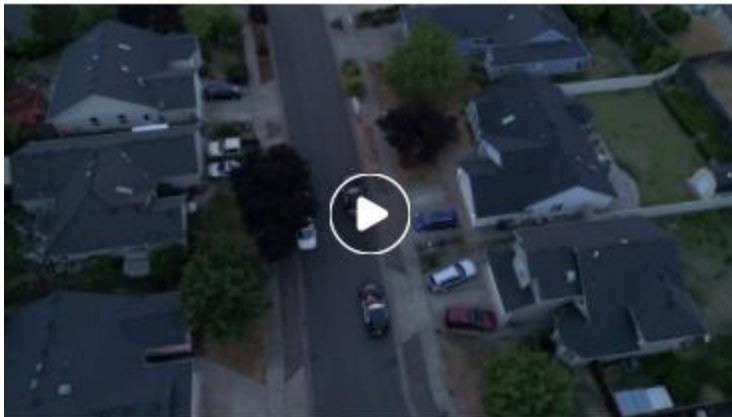

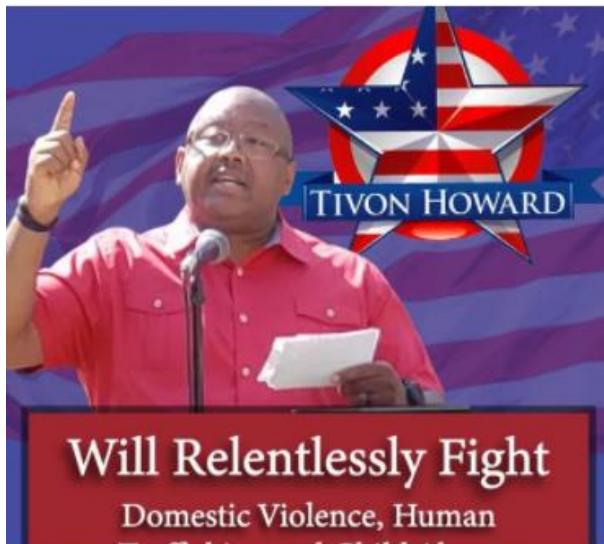

Tivon Howard's two most recent filed Organizational Statements, which appear to have been hand delivered to the Wake BOE. These two reports aren't reflected on the NC BOE campaign finance search. Furthermore, on the most recent update, they changed treasurers to Lane Houk, who is named in the initial complaint. Tivon Howard also updated his bank to First Citizens Bank.

Lane Houk, who paid over \$10,000 in one election cycle is also his treasurer. Furthermore, the bank accounts were switched to First Citizens from Bank of America. I would also like to add a potential connection. Shortly after filing the complaint, Donnie Harrison closed his original Facebook Page. They claimed it was an issue with Meta (Facebook) where they lost control of their account. As you can see from the screen shots, they unfollowed everyone and changed who managed the page. You can also see that large amounts of expenditures for “consulting” were paid during the same time at issue with Tivon Howard’s contributions.

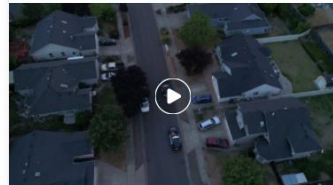

Under the totality of the circumstances, there are several indications of potential collusion among the two candidates. For example, Donnie Harrison closed his Facebook page shortly after I made the complaint, changed his Facebook moderator, unfollowed everyone, and large transactions equal to the amount in question during the time at issue would indicate the possibility. Furthermore, Tivon Howard’s campaign finance reports do not reflect any of these large transactions.

If you do see any additional internet advertisements, flyers, campaign materials, etc. that appear to be sponsored by the campaign that were not specifically identified in your complaint, I would appreciate if you could let me know and provide a copy or screenshot of the advertisement.





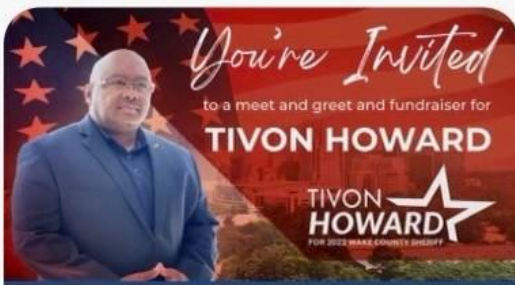
